- Our hash rate has declined in November because the number of computers we are operating has been declining since the end of October due to repair and replacement.
- We will introduce the mining machine from other manufacturers to the in-house mining. Our plan is to see our hash rate surpass 800 PH/s by the end of December.

- *1: Mining reward is gained as a result of mining cryptocurrencies. We are currently mining Bitcoin (unit: BTC) and Bitcoin Cash (unit: BCH).
- *2: Hash rate is an indicator of mining performance, the unit of which is H/s (the amount of computation per second). One PH/s means the amount of computation is 1 peta (1,000 trillion) times per second.
 - Hash rate is an important indicator for estimating our mining share. Our mining share depends on the market's total hash rate, so increased hash rate does not necessarily lead to increased mining reward. For each currency pair, profitability fluctuates and the allocation of hash rate is based on an algorithm. The above figures are as of the end of each month.
- *3: The Company shall disclose monthly information by the 5th business day of each month. Please note that the details of the disclosure and when the information will be disclosed may be subject to change without notice. Please note that the above is a preliminary data which may be subject to revision.
