### Notice Regarding Acquisition of Fixed Assets (GPU Servers)

GMO Internet Group, Inc. (the "Company") hereby announced that our Board of Directors has resolved at a meeting held on February 13, 2024 to acquire fixed assets (GPU Servers) as follows.

#### 1. Reason for the acquisition

GMO Internet Group is making a concerted effort to become the leading corporate group in creating the future with AI, under the banner "Towards Becoming No.1 Corporate Group in Creating the Future with AI."

In December last year, we signed a partnership contract with NVIDIA Corporation ("NVIDIA"), joining their "NVIDIA Partner Network," a partner program by NVIDIA, and have since been committed to promoting the domestic spread of GPUs.

In order to further strengthen our GPU hosting services, we plan to apply to the Ministry of Economy, Trade and Industry for a plan to secure the supply of the "Cloud Program," which is designated as a specified critical commodity under the Economic Security Promotion Act.

If this application is approved, we plan to accelerate our collaboration with NVIDIA and acquire GPU Servers worth approximately 10 billion yen.
